TERMS & CONDITIONS/EVALUATION CRITERIA FOR PERSONS/SHOPKEEPER APPEAR TO APPEAR IN BIDDING PROCESS

A. General Terms & Conditions:

- i. Firm/ Contractor must have at least a minimum of 3 years' experience of digital platform dealing.
- ii. Vendors must be financially stable and capable of providing ticketing services and receipt/payment of fare charges from/ to the passengers all the time
- iii. Vendors will be selected based on the locations specified in the table above, with preference given to those who own a shop at the specified location and are closest to the route.
- iv. Vendors must have adequate parking capacity for buses during passenger boarding and alighting, as well as for loading and unloading baggage.
- v. The committee will assess vendors based on prescribed criteria and can also carry out physical inspections/verifications if deemed necessary.
- vi. The bid shall be opened on 08th April 2025 at 02:00 pm at NATCO South Office Islamabad for destinations mentioned under Rawalpindi Station and at NATCO Headquarters Jutial Gilgit for remaining stations.
- vii. Companies or firms that set up a well-structured and fully equipped facility for the following services will be given preference.
- viii. A commission of 5% of the total cargo or passenger ticket amount will be allocated to the digital platform service provider.
- ix. The Company reserves the right to accept or reject the tender according to GBPPRA Rule-36(1).
