

TERMS & CONDITIONS/EVALUATION CRITERIA FOR FIRMS/CONTRACTORS TO APPEAR IN BIDDING PROCESS

A. **SCOPE OF WORK:**

Northern Areas Transport Corporation (NATCO) invites sealed bids from reputed manufacturers, authorized dealers, vendors, and suppliers for the supply of tyres for the financial year 2025–26. The tyres are required for NATCO's extensive and varied fleet, which includes buses, trucks, coasters, vans, and other official vehicles engaged in passenger and cargo transport services across multiple regions. The scope of work is as follows:

B. TERMS AND CONDITIONS:

- 1. **Terms & Conditions:** (The terms and conditions mentioned in the advertisement are required to be fulfilled. In addition, following specific conditions shall also be applicable for evaluation of bidding process)
 - 1. Single-stage, two-envelope bidding procedure shall be adopted, and evaluation shall be carried out on the basis of a 70:30 ratio, wherein 70% shall be for technical proposal and 30% to financial proposal.
 - i. The scope of work shall cover the supply of Tyres to NATCO throughout the financial year 2025–2026.
 - ii. Vendors must submit the mandatory documents listed under Serial No. C of the bid document to be eligible for technical evaluation; failure to do so will result in disqualification.
 - iii. Technical evaluation will be conducted based on criteria outlined in Serial No. D of the bid document.
 - iv. Financial proposals will be opened only for firms securing at least 60% marks in technical evaluation; those scoring below the threshold will be disqualified and their financial proposals returned unopened.
 - v. Experience shall be defined as a period of one year, from 1st July to 30th June of each financial year, in the provision of similar items. Vendors are required to submit a valid experience certificate or assignment completion certificate, which must be verifiable with the relevant department/offices.
 - vi. A supply order for provision of single items falling within the scope of required bid shall not be accepted as a valid experience for the purpose of this evaluation.
 - vii. Rates shall be quoted both item wise and in total, as per the prescribed format. Each page of the bid document must be properly signed and stamped by the vendor. The Corporation will recalculate the quoted amounts to ensure arithmetic accuracy and correct any errors in the total, if found.

- viii. NATCO has conducted a market survey to check current prices. If the quoted rates are too high or too low compared to market or manufacturer rates, they will be considered unreasonable and the bid will be rejected.
 - ix. Any additional tyre (s) not included in the list of items mentioned in this bidding document, if required during the financial year 2025–2026, shall be supplied by the vendor at prevailing market rates.
 - x. The selection of tyre brands shall only be made based on the specific requirements of the Corporation, and the most advantageous bid shall be evaluated accordingly. Mere submission of the lowest quoted rates does not automatically render a vendor eligible for the award of the bid.
