SCOPE OF WORK.

Northern Areas Transport Corporation (NATCO) invites sealed bids followed by an public auction for the disposal of its old, unserviceable, and surplus vehicles on an “as-is, where-is” basis for the year 2025–26. The auction details are as under:

2. AUCTION DOCUMENTS

Auction documents containing detailed terms and conditions may be obtained from the office of the General Manager (South), NATCO Islamabad and NATCO Head Office Gilgit upon payment of a non-refundable auction participation fee of Rs. 10,000/-.The amount shall be deposited in the official NATCO bank account : **Account Title: NATCO, Account No: PK36ALFH0119001003485687. Bank Alfalah.** No cash payment shall be accepted. Bidders downloading auction documents from any official source must also deposit the prescribed fee and attach the deposit slip with their sealed bid.

3. Terms & Conditions:

- i. Earnest money of Rs. 200,000/- must be submitted with the bid in the form of a demand draft or pay order made in favor of General Manager (South), NATCO Gilgit-Baltistan.
- ii. An affidavit of Rs. 100/- (original, prepared after the date of publication of this notice) must be attached with the bid, stating that the bidder has never been blacklisted by any Government or Semi Government organization, GBPPRA, or PPRA.
- iii. Bid must reach the office of General Manager, NATCO South, Plot No. 48, 1-11/4, Faqir Aipee Road, Islamabad, by 12:00 PM on 13th January, 2026. Open auction shall commence on the same day at 1:00 PM in the presence of the bidders or their authorized representatives.
- iv. Successful bidder shall make payment of 50% of winning auction amount in cash to the Cashier NATCO, on the same day of Auction and obtain an official receipt. Remaining amount must be paid within next seven (7) days; failing which, 50% advance payment and the CDR shall be forfeited in favor of NATCO.
- v. Successful bidders shall remove auctioned items from NATCO premises within seven (7) days after making full payment. Failing to do so will entitle NATCO to charge demurrage at the rate of 0.5% per day of the total bid amount.
- vi. Vehicles/items will be auctioned on an "as-is, where-is" basis.
- vii. NATCO reserves the right to accept or reject any or all bids in accordance with GB-PPRA Rule 36(1).

4. MANDATORY DOCUMENTS:

The following documents must be submitted along with the sealed bid:

1. Earnest Money (Pay Order / Demand Draft) from any scheduled bank
2. Duly notarized Non-Blacklisted Affidavit on stamp paper of Rs. 100/-
3. Deposit slip of non-refundable auction fee of Rs. 10,000/-

5. OPENING OF BIDS:

The Technical Proposals shall be opened on 13th January 2026 at the prescribed time at NATCO Office, Islamabad, in the presence of bidders or their authorized representatives. Financial Proposals of only technically qualified bidders shall be opened thereafter. Late bids shall not be accepted under any circumstances.

6. AUCTION PROCEDURE:

All vehicles offered by Northern Areas Transport Corporation (NATCO) shall be auctioned on an “**as-is, where-is**” basis. The vehicles shall be auctioned in two **(02) separate lots**. Interested bidders may inspect all vehicles included in both lots at the locations specified in the list, during official working hours, prior to the scheduled auction date and time. Participation in the auction shall be deemed as confirmation that the bidder has fully inspected the vehicles and is satisfied with their existing condition, quality, and status. No claim or objection regarding the condition or any deficiency of the vehicles shall be entertained after the auction.

7. MODE OF AUCTION:

The auction shall be conducted through a single-stage, two-envelope procedure consisting of Technical Proposal and Financial Proposal, followed by open auction. Bidders shall submit two (02) separate sealed envelopes, one containing the Technical Proposal and the other containing the Financial Proposal. Both these envelopes must be placed inside one outer sealed envelope, clearly Inscribed with the title of NATCO AUCTION, and name of the bidder. The Technical Proposals shall be opened first on the notified date and time at NATCO Office, Islamabad, in the presence of bidders or their authorized representatives. Only technically responsive bidders shall be allowed to participate in the opening of Financial Proposals and the subsequent open auction process.

8. FINANCIAL PROPOSAL (PRICE BID):

Bidders are required to submit their **Financial Proposal** in a separate sealed envelope clearly marked as FINANCIAL PROPOSAL. The Financial Proposal must quote the offered bid amount against each auction able item listed below. Rates once quoted shall be final and no conditional or alternative bids shall be accepted. All rates shall be quoted in Pak Rupees (PKR). Overwriting, cutting, or conditional pricing may result in rejection of the bid.

9. ELIGIBILITY OF BIDDERS

Any individual, firm, or contractor registered with relevant authorities and having valid CNIC / NTN (where applicable) is eligible to participate in the auction. Bidders must submit required documents as part of the Technical Proposal. NATCO reserves the right to verify bidder credentials.

10. RIGHT OF THE CORPORATION

NATCO reserves the right to cancel, postpone, re-auction, or modify the auction process at any stage in accordance with applicable rules, without assigning any reason.

11. AWARD OF AUCTION

The highest bid shall be recommended to the competent authority for approval. NATCO reserves the right to accept or reject any or all bids without assigning any reason.

12. TAXES & DUTIES

All applicable taxes, duties, levies, and registration cancellation charges shall be borne by the successful bidder. NATCO shall not be responsible for any tax liability after delivery.

13. DISPUTE RESOLUTION

In case of any dispute, the decision of the competent authority of NATCO shall be final and binding.

14. REMOVAL OF AUCTIONED ITEMS & ASSOCIATED COSTS

The successful bidder shall be required to remove the auctioned vehicles or items from the NATCO premises within the prescribed time. All expenses related to removal, including transportation, loading and unloading, registration cancellation charges, and any other incidental costs, shall be borne solely by the successful bidder. NATCO shall not be liable for any financial or legal responsibility in this regard. In case of failure to remove the auctioned vehicles or items within the stipulated time, NATCO shall be entitled to charge demurrage at the rate of **0.5% per day of the total bid amount**.
