TERMS & CONDITIONS/EVALUATION CRITERIA FOR FIRMS/CONTRACTORS TO APPEAR IN BIDDING PROCESS

A. SCOPE OF WORK:

Northern Areas Transport Corporation (NATCO) invites sealed bids from reputed manufacturers, authorized dealers, vendors, and suppliers for the supply of tyres for the financial year 2026–27. The tyres are required for NATCO’s extensive and varied fleet, which includes buses, trucks, coasters, vans, and other official vehicles engaged in passenger and cargo transport services across multiple regions. International bidders may participate in this tender through their authorized local dealers or representatives. The scope of work is as follows:

2. Tender documents containing detailed terms and conditions can be obtained from office of the Manager (Admin), NATCO Head Office Gilgit, and General Manager (South), NATCO Islamabad, upon payment of a non-refundable fee of Rs. 10,000/-, to be deposited in the official account titled “**PK36ALFH0119001003485687 - NATCO**”. No cash payment shall be accepted under any circumstances. Firms downloading documents from NATCO website are also required to deposit said amount and attach deposit receipt with their technical proposal.

3. GENERAL TERMS AND CONDITIONS:

- i. Earnest money, in the form of a Call Deposit from any scheduled bank, must be submitted along with the Technical Proposal, in favour of the General Manager, NATCO. The Call Deposit must not be included with the Financial Proposal under any circumstances; doing so will result in disqualification from the technical evaluation.
- ii. Parties with proven expertise in supply of tyres are eligible to apply. Preference shall be given to vendors with a strong track record of supplying high quality tyres to public sector entities or large scale transport companies, and who can ensure timely delivery in accordance with the specifications required by the Corporation.

- iii. Proposals must be submitted by the date, time, and venue specified above and will be opened the same day in presence of the vendors or their authorized representatives.
- iv. Vendors are required to submit a valid business registration certificate along with the Technical Bid. NATCO reserves the right to verify authenticity of submitted documents directly from issuing authority. Incomplete bids or those lacking required documentation shall not be considered. Furthermore, submission of false or misleading information will result in immediate disqualification and may also lead to legal action under the applicable laws.
- v. An affidavit on stamp paper of Rs. 100/- must be accompanied with the tender documents to the effect that the bidder has never been blacklisted by any Government/Semi-Government Organization/ PPRA/GBPPRA.
- vi. Single-stage, two-envelope bidding procedure shall be adopted, and evaluation shall be carried out on the basis of a 70:30 ratio, wherein 70% shall be for technical proposal and 30% to financial proposal.
- vii. The selected vendor shall not be entitled to demand or assume any fixed quantity of purchase. NATCO will place supply orders solely based on its actual requirements, as determined from time to time during the contract period.
- viii. Vendors must possess a minimum of 5 years of proven experience in the manufacturing or dealership of supply of tyres. Relevant supply orders, experience certificates, or other credible documentary evidence must be submitted along with the Technical Bid. Bids lacking verifiable proof of the required experience shall be rejected and not considered for further evaluation.
- ix. Vendors must be financially stable and are required to provide a bank statement covering the period from January 1st, 2025, to May 31st, 2026 (16 months).
- x. Detailed information regarding tyre sizes, specifications, financial stability, and other eligibility requirements will be provided in bid documents. Vendors shall be evaluated in accordance with the criteria specified therein. NATCO reserves the right to conduct physical inspections or verifications, if deemed necessary, to confirm the authenticity of the vendors' claims and their capabilities.
- xi. The Corporation reserves the right to accept or reject the tender according to GBPPRA Rule-36(1).
